#### **Job Description**

### 2.1. Purpose

The Cloud & Infrastructure Solution Architect will architect and design cloud and infrastructure systems in line with the overall enterprise cloud and infrastructure architecture and in accordance with the needs of the business. They will work with the Enterprise Cloud & Infrastructure Architect to assure the cyber-security needs of the business and to deliver the Information Security Strategy for the University Group.

The post holder will have an excellent understanding of technology and technology trends within the field of cloud and infrastructure technology. They will apply this insight to enable the business to innovate through the use of technology.

They will pro-actively scan the market and look to bring in emerging technologies that the University Group might lever for competitive advantage.

The post will be line-managed by the Enterprise Cloud & Infrastructure Architect and will work closely with other solution architects across disciplines in order to build effective solutions for the University Group.

# 2.2. Main Duties and Responsibilities

- Leads the development of solution architectures for specific cloud and infrastructure systems. Ensures that appropriate tools and methods are available, understood and employed in architecture development. Within a change programme, leads the preparation of technical plans and, in liaison with business assurance and project staff, ensures that appropriate technical resources are made available. Provides advice on technical aspects of solution development and integration and ensures that relevant technical strategies, policies, standards and practices (including security) are applied correctly.
- 2. Actively maintains recognised expert level knowledge in cloud and infrastructure technologies. Provides definitive and expert advice in cloud and infrastructure technologies. Oversees the provision of specialist advice by others, consolidates expertise from multiple sources, including third party experts, to provide coherent advice to further organisational objectives. Supports and promotes the development and sharing of specialist knowledge within the organisation.
- Takes responsibility for the design, procurement, installation, upgrading, operation, control, maintenance and effective use of IT cloud and infrastructure components and

monitors their performance. Provides technical management of IT cloud and infrastructure, ensuring that agreed service levels are met and all relevant policies and procedures are adhered to. Schedules and supervises IT cloud and infrastructure maintenance and installation work. Ensures that operational problems are identified, recorded, monitored and resolved. Provides appropriate status and other reports to specialists, users and managers. Ensures that operational procedures and working practices are fit for purpose and current. Investigates and manages the adoption of appropriate tools, techniques and processes (including automation) for the management of systems and services.

- 4. Provides advice and guidance on security strategies to manage identified risks and ensure adoption and adherence to standards. Obtains and acts on vulnerability information and conducts security risk assessments, business impact analysis and accreditation on complex information systems. Investigates major breaches of security, and recommends appropriate control improvements. Contributes to development of information security policy, standards and guidelines.
- 5. Reviews current and proposed cloud and infrastructure systems for compliance with the organisation's obligations (including legislation, regulatory, contractual and agreed standards/policies) and adherence to overall strategy. Provides specialist advice to those accountable for governance to correct compliance issues.
- 6. Maintains an awareness of the global needs of the organisation. Promotes (to both information systems and business management) the benefits that a common approach to information and communications technology deployment will bring to the business as a whole. Coordinates the promotion, acquisition, development, and implementation of cloud and infrastructure systems and services in close liaison with those responsible for management and strategy.
- 7. Manages the cloud and infrastructure innovation pipeline and executes innovation processes. Develops, evolves and adapts innovation tools, processes and infrastructures to drive the process of innovation. Identifies resources and capabilities needed to support innovation. Encourages and motivates innovation communities, teams and individuals to share creative ideas and learn from failures. Manages and facilitates the communication and open flow of creative ideas between interested parties and the set-up of innovation networks and communities.
- 8. Monitors the external environment to gather intelligence on emerging cloud and infrastructure technologies. Assesses and documents the impacts, threats and opportunities to the organisation. Creates reports and technology roadmaps and shares knowledge and insights with others.
- 9. Provides advice, guidance and expertise to promote adoption of methods and tools and adherence to policies and standards. Evaluates and selects appropriate methods and tools in line with agreed policies and standards. Implements methods and tools at programme, project and team level including selection and tailoring in line with agreed standards.

Manages reviews of the benefits and value of methods and tools. Identifies and recommends improvements. Contributes to organisational policies, standards, and guidelines for methods and tools.

10. Adopts and adapts appropriate systems design methods, tools and techniques selecting appropriately from predictive (plan-driven) approaches or adaptive (iterative/agile) approaches, and ensures they are applied effectively. Designs large or complex systems. Undertakes impact analysis on major design options and trade-off. Makes recommendations and assesses and manages associated risks. Reviews others' systems designs to ensure selection of appropriate technology, efficient use of resources, and integration of multiple systems and technology. Ensures that the system design balances functional and non-functional requirements. Contributes to development of systems design policies and standards and selection of architecture components.

Deputises for the Enterprise Cloud & Infrastructure Architect as required.
